

Which TYPE OF GIFT?

There are a number of ways in which you can leave a gift in your will.

Your solicitor can advise you on the most appropriate type of gift and the wording of your will. We can provide you with example wording to review with your solicitor.

These are the most common types of gifts that you can leave in your will:

Residuary gift

A percentage of your remaining estate, after fees, outstanding costs and other gifts have been taken care of. The advantage of a residuary legacy gift is that it keeps up with inflation as it is not a fixed sum.

Pecuniary gift

A fixed sum of money. The value of pecuniary legacies will decrease over time, as the cost of living increases. However, you can link your legacy to the Retail Price Index to ensure that the gift you choose today is worth the same in the future.

Conditional legacy

This provides for the possibility that if one of your named beneficiaries does not survive you, that part of your estate will be left to the University.

Pension benefits

Nominating the University as a beneficiary in your pension or SIPP (Self Invested Personal Pension).

Other gifts

A tax-free gift of land, buildings, personal property (such as antiques or jewellery), shares or securities.

Tax Benefits AND OTHER THINGS TO CONSIDER

United Kingdom: The University of York is an exempt charity under Schedule 3 of the Charities Act 2011. As such, any gift within your will falls outside of inheritance tax. Giving as part of your will can help to reduce your estate's inheritance tax bill.

If you leave something to charity in your will, then it will not count towards the total taxable value of your estate. This is called leaving a 'charitable legacy'.

You can also cut the Inheritance tax rate on the rest of your estate from 40% to 36%, if you leave at least 10% of your net estate to charity.

United States: The University of York in America is a non-profit organisation and a separate legal entity from the University. Donations to the University of York in America are tax-deductible and it is a 501(c)(3) organisation (EIN number: 30-0241333). A bequest to the University of York in America, an organisation exempt from taxes, can reduce your estate tax.

Canada: If you are a resident in Canada your bequest could reduce the tax payable on your estate. The University of York has been granted Prescribed University Status with the Canada Revenue Agency.
